# **Council and Main Committees**

## **Council of the University**

#### **Changes to Regulations**

Council has made the following changes to regulations, to come into effect on 5 April.

#### (a) Convocation Elections

#### **Explanatory Note**

The following changes are being made to align the arrangements for the election of a Chancellor of the University with the other election by Convocation and to increase inclusivity.

#### Text of Regulations

In <u>Council Regulations 8 of 2002</u>, concerning Convocation elections, delete the section on the Election of the Chancellor, and insert the following:

#### 'Regulations for Convocation Elections

1. An election in Convocation shall be held in Full Term, unless Council shall order otherwise, on a date fixed by Council.

#### **Election of the Chancellor**

- 2. The election to fill a vacancy shall take place as soon as may be after the occurrence of the vacancy (subject to the provisions of regulation 1 above).
- 3. The Chancellor shall be elected in accordance with the following procedure:
  - (1) The Chancellor's Election Committee shall oversee the election process.
  - (2) The committee shall consist of:
    - (a) the High Steward, who shall chair the committee;
    - (b) the Vice-Chancellor, who shall be deputy chair of the committee:
    - (c) one person appointed by Council from among current external members of Council;
    - (d) two members of Council appointed by Council from among the members of Council specified in section 4 (16)–(26) of Statute VI;
    - (e) one member of Congregation to be appointed by the Gardens, Libraries and Museums, University Administrative Services and the Department for Continuing Education:
    - (f)–(i) one member of Congregation appointed by each of the divisional boards;

- (j) the early career research staff representative who attends Council;
- (k) the Chair of the Conference of Colleges;
- (3) The committee may co-opt up to two additional members for such periods as the committee shall deem appropriate.
- (4) The committee shall report to Council as necessary.
- (5) The committee shall be responsible for:
  - (a) determining the timeline for the election process, including the date by which applications must be received and the date of the election;
  - (b) approving the role specification for the post and determining the information to be provided by candidates:
  - (c) recommending to Council the term of office for each new Chancellor election.
- (6) The date of the election is the day the poll closes, after which time it is no longer possible to cast a vote: and not the date the results are announced.
- (7) After the closing date for applications, the committee shall consider all those it has received, and, having due regard to the principles of equality and diversity and the approved role specification, shall determine which candidates are eligible to progress to the next stage of the election process.
- (8) If the committee determines that only one candidate will progress to the next stage of the selection process or if only one candidate remains after other candidates have withdrawn, Council will be required to determine whether that candidate shall be deemed to be duly elected and the result published in the University *Gazette* or if further applications should be sought to allow an election to be held.
- (9) If the committee determines that no candidate is eligible to progress to the next stage of the selection process, or all have withdrawn, Council shall invite further applications to allow an election to be held.

- (10) If the committee determines that more than one candidate will progress to the next stage of the selection process, an election by Convocation shall be held as follows:
  - (a) Voting shall be online.
  - (b) The electoral system shall be decided by the Chancellor's Election Committee.
- (c) The Registrar shall be responsible for the counting of the votes but the Vice-Chancellor and Proctors shall decide on the validity of any vote which, in the opinion of the Registrar, is in doubt.
- (d) In the case of an equality of votes, the Chair of the Chancellor's Election Committee shall decide between the candidates.
- (e) The result of the election shall be published in the University *Gazette*.'

#### (b) Regulations for the Employment of University Staff

#### **Explanatory Note**

The following changes have been made, at the request of the Humanities, Mathematical, Physical and Life Sciences, and Medical Sciences Divisions and Continuing Education and Gardens, Libraries and Museums to enable the title of Professor of Practice to be used in appropriate cases in all those areas, including for staff on grades 9 and 10.

#### Text of Regulations

In <u>Council Regulations 3 of 2004</u>, concerning the employment of University staff, amend as follows (new text underlined, deleted text struck through):

'Regulations for the Employment of University Staff

- 9. The following persons shall be eligible to apply for the title of professor of practice:
  - (1) all those in the grades 9, 10 and of RS IV in the Social Sciences Division; and
  - (2) all those in the grade of associate professor in the Social Sciences Division.'

#### (c) Regulations for the Student Fitness to Study Panel

#### Explanatory Note

The following changes have been made to align with a restructure of the subcommittees of Education Committee that came into force on 5 May 2023, which disbanded the Student Wellbeing Subcommittee of the Education Committee and the Joint Subcommittee of the Education Committee with Student Numbers, and established the Student Life Subcommittee of the Education Committee to oversee extra-curricular and non-academic student matters.

#### Text of Regulations

In <u>Council Regulations 1 of 2012</u>, concerning Regulations for the Student Fitness to Study Panel, amend Part 6: Annual Report, as follows (new text underlined, deleted text struck through):

'Regulations for the Student Fitness to Study Panel

Part 6: Annual Report

6.1. The Panel shall provide an annual report on its activities, making recommendations as appropriate, to the Student WellbeingLife Subcommittee of the Education Committee.'

# (d) Regulations for Committees Reporting Directly to Council or one of its Main Committees: Education Committee

#### Explanatory Note

The following changes have been made to reflect a change in membership following amendments to the name of one panel reporting to the Education Committee, a restructure of the subcommittees of the Education Committee that came into force on 5 May 2023, and also to remove gendered language.

#### Text of Regulations

In <u>Part 2 of Council Regulations 15 of 2002</u>, concerning Education Committee, amend as follows (new text underlined, deleted text struck through):

'Regulations for Committees Reporting Directly to Council or one of its Main Committees

2.1 The Education Committee shall consist of:

(13) the Chair of the Taught Degrees <u>and Awards</u> Panel;

(16) the Chair of the Student Wellbeing Subcommittee the Chair of the Student Life Subcommittee;

- (3) Decisions on applications will be made on behalf of Education Committee by the Pro-Vice-Chancellor (Education) or <a href="historycolor: blue of the beautiff">historycolor: blue of the beautiff</a>.
- (4) An applicant who is dissatisfied with a decision made on behalf of Education Committee, may, or his or

hertheir college or department may, appeal against it. An appeal must be made within fourteen days of the date of Education Committee's decision. Any such appeal must be made in writing. The appeal will be heard by two members of Education Committee with no previous connection to the case.'

# (e) Regulations for Committees Reporting Directly to Council or one of its Main Committees: Education Committee

#### **Explanatory Note**

The following changes have been made to formalise the Graduate Admissions Committee as a subcommittee of Education Committee; and to establish a new subcommittee of Education Committee to provide direction for University-led activities which support people with displacement backgrounds.

#### Text of Regulations

In <u>Council Regulations 15 of 2002</u>, concerning 'Other committees', add Parts 40 and 41 as follows:

'Regulations for Committees Reporting Directly to Council or one of its Main Committees

# Part 40: Graduate Admissions Committee: Subcommittee of the Education Committee

- 40.1 The Graduate Admissions Committee shall consist of:
  - (1) the Pro-Vice-Chancellor (Education), or their nominated deputy, who shall chair the Committee;
  - (2)–(5) the Associate Head of Education or their nominee from each Division;
  - (6) the Associate Head of Education or their nominee from the Department for Continuing Education;
  - (7) the Chair of the Graduate Committee of the Conference of Colleges or their nominee;
  - (8) a Head of House elected by the Conference of Colleges;
  - (9) a Tutor for Graduates elected by the Conference of Colleges;
  - (10) a Bursar or Domestic Bursar elected by the Conference of Colleges;
  - (11) one of the sabbatical trustees of Oxford University Student Union as may be agreed between them;
  - (12) the Director of Graduate Admissions and Recruitment;
  - (13) the Director of Student Fees and Funding;

- (14) the Head of Residential Accommodation;
- (15) a representative from Education Policy Support.
- 40.2 With the approval of the Education Committee on each occasion, the Subcommittee may co-opt up to two additional members.
- 40.3 Elected, appointed or co-opted members shall hold office for a period of three years and shall be eligible to serve for a total period of six years.
- 40.4 The Graduate Admissions Committee shall be responsible to Education Committee for:
  - (1) steering strategic change to bring transformative developments in graduate admissions;
  - (2) championing the applicant experience;
  - (3) owning the end-to-end graduate admissions process, including oversight of graduate accommodation, setting a vision for the overall process in accordance with the University's Strategic plan, and monitoring and evaluating progress against the targets set in the Plan;
  - (4) establishing the roadmap to the One Offer vision, agreeing key data and improvement targets, and establishing the appropriate activities required to make progress;
  - (5) advocating and supporting all opportunities for streamlining and improving the current overall process;
  - (6) raising the profile of the graduate admissions process internally in light of the increasing significance of graduate applicants in overall student numbers.
- 40.5 The subcommittee will make an annual report to Council via Education Committee on the work of the Subcommittee.
- 40.6 The subcommittee shall meet at least twice per year.

#### Part 41: The University of Sanctuary Steering Committee: Subcommittee of Education Committee

- 41.1. The University of Sanctuary Steering Committee shall consist of:
  - (1) a chair appointed by the Vice-Chancellor on the recommendation of Education Committee:
  - (2) a representative of the University's Refugee Studies Centre:
  - (3) a representative from Colleges with College of Sanctuary Status;
  - (4) the Head of Student Fees and Funding, or their nominee:
  - (5) one of the sabbatical trustees of Oxford University Student Union as may be agreed between them;
  - (6) a representative from Oxford University Development Office;
  - (7) a person elected by the Conference of Colleges;
  - (8)–(11) four persons elected by the Divisions;
  - (12) a representative of City of Sanctuary;
  - (13) the University's designated coordinator for Oxford Sanctuary Community (or equivalent);
  - (14) a student representative current student with lived experience of forced displacement;
  - (15–16) up to two external members with relevant expertise.
- 41.2. Other members of the University will be invited to attend meetings for relevant agenda items.

- 41.3. With the approval of the Education Committee on each occasion, the subcommittee may co-opt up to two additional members
- 41.4. Elected, appointed or co-opted members shall hold office for a period of three years and shall be eligible to serve for a total period of six years.
- 41.5. The University of Sanctuary Steering Committee shall be a subcommittee of Education Committee and shall be responsible to Education Committee for the oversight and strategic direction of University activities which support people with displacement backgrounds.
- 41.6. In the exercise of its responsibilities the Steering Committee shall:
  - (a) provide strategic direction for University-led activities which support people with displacement backgrounds;
  - (b) monitor progress in achieving the actions identified in the institutional University of Sanctuary Award;
  - (c) oversee new and existing University scholarship schemes which support people with displacement backgrounds;
  - (d) oversee renewal applications for the University of Sanctuary Award;
  - (e) review, assess, and award College of Sanctuary status to individual Oxford colleges and private halls based on clearly defined criteria;
  - (f) make an annual report to Council via Education Committee on the work of the subcommittee.
- 41.7. The subcommittee shall meet at least twice per year.'

#### (e) Regulations for the Committee for the Ruskin School of Art

Explanatory Note

The following changes have been made to ensure that the Head of the Ruskin School of Art chairs the Committee for the Ruskin School of Art.

#### Text of Regulations

In <u>Council Regulations 2 of 2004</u>, Regulations for other University Bodies, amend the section concerning the Committee for the Ruskin School of Art, as follows (new text underlined, deleted text struck through):

- '7.1. There shall be a Committee for the Ruskin School of Art consisting of:
  - (1), (2) two persons appointed by the Humanities-Board, one of whom shall chair the committee;

(1) The Head of the Ruskin School of Art, who shall chair the committee;

(2) One person appointed by the Humanities Board;

(3)–(14) (13) up to twelve persons holding the post of Professor or Associate Professor in the Ruskin School of Art:

(15) (14) a person appointed by the Committee of Senior Tutors.'

#### (a) Regulations for the St Cross Scholarships in European Medieval Archaeology Fund

Explanatory Note

Text of Regulations

These new regulations are made to formalise the trust created by the receipt of the gift from Sonia Hawkes-Petkovic.

In <u>Council Regulations 25 of 2002</u>, concerning Trusts, insert:

- 'St Cross Scholarships in European Medieval Archaeology Fund
- 1. The University receives with gratitude gifts from Sonia Hawkes-Petkovic to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the St Cross Scholarships in European Medieval Archaeology Fund ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the creation and maintenance of scholarships in European Medieval Archaeology.
- 4. The administration of the Fund, and the application of its income, shall be the responsibility of St Cross College.
- 5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such

- accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.
- 6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the Scholarships.
- 7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 8. These Regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (b) Regulations for the St Cross Uehiro Scholarships for Future Generations Fund

#### **Explanatory Note**

These new regulations are made to formalise the trust created by the receipt of the gift from the Uehiro Foundation on Ethics and Education.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning Trusts, insert:

- 'St Cross Uehiro Scholarships for Future Generations Fund
- 1. The University receives with gratitude gifts from the Uehiro Foundation on Ethics and Education to be held as permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the St Cross Uehiro Scholarships for Future Generations Fund ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the creation and maintenance of scholarships and supporting students studying within the field of practical ethics.
- 4. The scholarships shall be called the St Cross Uehiro Scholarships for Future Generations.
- 5. The administration of the Fund, and the application of its income, shall be the responsibility of St Cross College.
- 6. The University may in its absolute discretion in the period ending 21 years from the date of this regulation,

instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

- 7. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the Scholarships.
- 8. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

- 9. These Regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI
- 10. Subject to regulation 11, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 11. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (c) Regulations for the Palgrave Brown Bursary Fund

#### **Explanatory Note**

The following changes have been made to change the Board of Management for the fund and add in up-to-date trust provisions, as required.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning the Palgrave Brown Bursary Fund, amend the regulations, as follows (new text underlined, deleted text struck through):

#### 'Palgrave Brown Bursary Fund

- 1. The gift from the Alan Palgrave Brown Will Trust which comprises one million pounds sterling (£1,000,000), together with any further donations for this purpose, shall be known as the Palgrave Brown Bursary Fund ("the Fund").
- 2. The University shall retain all of the Fund as a permanent endowment and shall apply the net income of the Fund towards providing bursaries for undergraduate students of the University who are in need of financial assistance towards tuition fees and/or living costs; and are or were previously resident or educated in either the United Kingdom counties of Norfolk or Suffolk or Albania, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, the Czech Republic, Estonia, Georgia, Hungary, Kazakhstan, Kyrgyzstan, Latvia, Lithuania, Moldova, Montenegro, Republic of Macedonia, Serbia Slovakia, Slovenia, Tajikistan, Turkmenistan, Poland, Romania, Russia, Ukraine, Uzbekistan.

- 3. The administration of the Fund, and the application of its income, shall be the responsibility of the Enhanced Bursaries Committee Undergraduate Scholarship Selection Panel.
- 4. Regulation 3 above may be amended by Council.
- 4. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, the management and administration of the Fund and the Scholarship.
- 5. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 6. These regulations shall be deemed to be Trust
  Regulations under the provisions of Part D of Statute
  XVI.
- 7. Subject to regulation 8, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 8. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (d) Regulations for the Vivien Leigh Fund

#### Explanatory Note

The following changes have been made to remove duplicate Trust Regulations and add in up-to-date trust provisions, as required.

#### Text of Regulations

<u>In Council Regulations 25 of 2002</u>, concerning the Vivien Leigh Fund, amend the regulations, as follows (new text underlined, deleted text struck through):

#### 'Vivien Leigh Fund

- 1. The benefaction from Miss Vivien Leigh deceased, together with subsequent donations raised by appeal or received for the purpose, shall be known as the Vivien Leigh Fund.
- 2. The University shall retain all of the fund as permanent endowment and shall apply the net income of the Fund for the encouragement of young artists or artists at an early stage in their career and in particular to fund the Vivien Leigh Prize for a work of art by an undergraduate member of the University.
- 3. The administration of the Fund, and the application of its income, shall be the responsibility of the Visitors of the Ashmolean Museum, who shall delegate responsibility to the Keeper of Western Art acting in consultation with the Director of the Ashmolean Museum.

#### 4. Regulation 3 may be amended by Council

- 4. The University shall have the power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund.
- 5. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 6. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 7. Subject to regulation 8, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 8. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (e) Regulations for the Ashmolean Museum of Art and Archaeology

#### Explanatory Note

The following changes have been made to remove duplicate Trust Regulations.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning the Ashmolean Museum of Art and Archaeology, amend the regulations, as follows (deleted text struck through):

#### **Leigh Bequest**

The bequest of £1,000 from the late Miss Vivien Leighshall be expended at the discretion of the Keeper of Western Art, Ashmolean Museum, in such manner as he or she thinks will best serve the interests of art, including the education of members of the University in artistic matters and the assistance of young artists of promise.'

#### (f) Regulations for the Sarah J. Clackson Coptic Fund

#### Explanatory Note

The following changes have been made to add in upto-date trust provisions, as required, and to clarify the binding trust purpose and other obligations.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning the Sarah J. Clackson Coptic Fund, amend the regulations, as follows (new text underlined, deleted text struck through):

#### 'Sarah J. Clackson Coptic Fund

- 1. The sums contributed by friends and colleagues in memory of Sarah J. Clackson will provide travel and research grants to anyone undertaking work on Coptic manuscripts including the viewing, preparation, and recording of the material, but not conservation.
- 2. The Board of the Faculty of Oriental Studies shall be the board of management for the fund, and shall determine the value of the awards and the terms on

which they are awarded. Any unspent income which is not re-invested or carried forward for use in subsequent years may be applied at the discretion of the board of management in some other way consistent with the promotion of the study of Coptic.

- 3. Regulation 2 above may be amended by Council
- 2. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts.
- 3. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 4. The administration of the Fund, and the application of its income, shall be the responsibility of the Board of the Faculty of Asian and Middle Eastern Studies.
- 5. Any unspent income may be applied at the discretion of the Board of Management in some other way consistent with the promotion of the study and/or research of Coptic.
- 6. The University shall have power to pay out of the capital or the income of the Fund all costs of

- and incidental to the creation of the Fund and the management and administration of the Fund.
- 7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 8. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### Voting on Legislative Proposal: Statute IX, Officers of the University

#### **Explanatory Note**

The following changes have been made to time limit the role of the Chancellor, in recognition of it being an unremunerated post and to permit the flexibility to alter the duration of the period of office to prevent the coincidence of a newly appointed Vice-Chancellor and a new elected Chancellor.

#### Text of Legislative Proposal

WHEREAS it is expedient to make changes to the arrangements for the office of the Chancellor, THE UNIVERSITY ENACTS AS FOLLOWS. In Statute IX, concerning Officers of the University, amend as follows (new text underlined, deleted text struck through):

- '2. The Chancellor shall be elected by Convocation and shall hold office <u>for a fixed period decided by Council</u> during his or her life or until his or her their resignation.
- 3. There shall be a Chancellor's Court of Benefactors to membership of which the Chancellor may from time to time admit major benefactors of the University.
- 4. The Chancellor shall have such other functions and powers as are assigned to <a href="him or herthem">him or herthem</a> by the statutes and regulations or by the law of the land.'

#### **Meeting information**

Members of Congregation are reminded that any two members may, not later than **noon on 15 April**, give notice in writing to the Registrar that they wish to oppose or amend the legislative proposal above (see the note on the conduct of business in Congregation

below). If no such notice has been given, and unless Council has declared otherwise or the meeting has been adjourned, the legislative proposal shall be declared approved, and the meeting may be cancelled.
